

# PSCA Meeting Minutes

### Call to Order:

- The meeting was called to order at 7:05 PM by *Ricky*

### Previous Meeting Minutes:

- The *February* meeting Minutes were emailed to *Board* members prior to the meeting.
- After reviewing, *Andy* motioned to accept the *February* meeting *Minutes*. The motion was seconded by *Eric* with all present in favor.

### Treasurer's Report:

- Copies of the *Treasurer's Report* were emailed to *Board* members prior to the meeting. After a brief review by *Andy*, *Jeff* motioned to accept the *Treasurer's Report*. Motioned was seconded by *Eric* with all parties in favor.

### Old Business:

- *Eric* gave an update on the *State Shoot...*
  - Work has started on the exit road with will allow traffic to flow in one direction into and out of the property.
  - The *Concurrent* trophies have arrived.
- Prior to the meeting *Ricky* emailed the *Board* members proposals for *Main, Prelim, FITASC, Sub Gauges, Pump and SxS* trophies. After a brief review *Andy* motioned to allow *Ricky* to place the orders for the proposed trophies. Motion seconded by *Jeff* with all parties in favor.
- *2016* target fees generated a total of \$7,000 which will be used as *Back-To-Class* monies at this year's *State Shoot*. The money will be split between *ALL NSCA Classes (M – E)* in the *State Shoot Main Event* as follows: \$300 / \$250 / \$200 / \$150 / \$100. *Ricky* will post this information on the shotgun forums.

### New Business:

- There was discussion concerning a letter received from *Randy Shirk* requesting the current *NSCA Classification Review* restriction be lifted. The restriction was put in place against *Randy* by the *PSCA Board* several years ago. *Ricky* pointed out that *Randy* has shot no registered targets this year and 300 registered targets last year. It was also discussed that only last year the *PSCA Board* voted to lift the restriction against *Randy*, only to have complaints about him at a shoot two (2) days later, leaving the *PSCA Board* no option but to re-impose the restriction. *Ricky* will email the *PSCA Board* in preparation for a future vote on *Randy's* request.
