

PSCA Meeting Minutes

Friday, June 28th, 2013

Call to Order:

- The meeting was called to order at **7:05 PM** by *Ricky*.

Previous Meeting Minutes:

- Copies of the *May* meeting *Minutes* were emailed to all Board members prior to the meeting.
- *Mike Brendle* motioned to accept the *May* meeting *Minutes*. The motion was seconded by *Warren* with all parties in favor.

Treasurer's Report:

- Copies of the *Treasurers Report* were emailed to all Board members prior to the meeting.
- *Mike Koneski* motioned to accept the *Treasurers Report*. Motion was seconded by *Warren* with all parties in favor.

Old Business:

- *Mark Hull* gave a review of this year's *Western Zone*, summarizing that the attendance was disappointing. *Ricky* mentioned that he had heard a few complaints about the *Eastern Zone*, and did ask other shooters if they had any similar complaints, but there was not a majority raised on any one issue. *Ricky* also mentioned that he thought that the *SCTP State Shoot* went well, however *Mark* mentioned he had heard otherwise, e.g. kids and parents unhappy with the targets and the club running out of food.
- *Mike Brendle* gave an update on the preparations for the State Shoot.
 - All the trophies have been delivered.
 - 81 flats of shells for the *PSCA Shell Game* have been delivered.
 - Finishing touches are being put on the new pavilion.
 - Online registration is progressing with 200+ total shooters so far...they are beginning to add "B" squad at some stations to accommodate the number of shooters.
 - *Krieghoff* and *Benelli* have donated items which will be raffled off to shooters of the *Pyramid-Wobble*...one (1) ticket per 11 straight broken targets. Three (3) tickets if the shooter "runs" the *Pyramid-Wobble*.

- Mike also mentioned that in an attempt to reduce back-ups/bottle-necks he would like to limit the number of “show” targets to *two (2)* or *three (3)* pairs per squad.
- *Ricky* mentioned that the PSCA had purchased 200 \$10 gift cards from Dicks Sporting Goods that were given away to the SCTP shooters at the *SCTP State Shoot*. However, since there were 208 entries at the shoot, 8 shooters did not receive a gift card. *Mike Koneski* motioned that *Ricky* purchase 8 additional \$10 gifts card for the shooters that did not receive one. Motion was seconded by *Mark Hull* with all parties in favor. *Ricky* will purchase the additional gift cards and get them to the SCTP shooters.

New Business:

- *Mike Koneski* asked that *Rock Mountain* be allowed to move the date of next year’s *Eastern Zone*, due to scheduling conflicts. The selected date being the *June 28th – 29th 2014*. *Mike Brendle* motioned that *Rock Mountain* be allowed to move the *Eastern Zone Shoot* to that date. Motion was seconded by *Andy* with all parties in favor.
- There was some discussion dealing with the lack of applications for *Zone Shoots*. The discussion dealt with whether to eliminate one or both of the *Zone Shoots*. It was decided to add as an item to the agenda for the *State Shoot* meeting to allow input from the shooters.
- There was discussion about changing the PSCA fiscal year from *September 1st – August 31st* to *January 1st – December 31st*. *Mark* motioned that the PSCA fiscal year be changed to *January 1st – December 31st*. Motion seconded by *Mike Koneski* with all parties in favor.
- *Ricky* informed those present that *Peter Hontz* had decided to step-down as the *PSCA Secretary*.
- *Ricky* informed those present that he had received one (1) *State Shoot* application for the 2015 year, submitted by *Buffer Creek*. There was some discussion about the application being received after the “*deadline*”, but everyone agreed that since there were no other applications submitted prior to the deadline, this was a non-issue. It was also agreed that should any other applications be received prior to the *State Shoot*, shooters at this year’s *State Shoot* would have the opportunity to select which of the applying clubs will hosts the *2015 State Shoot*.

Next Meeting date and location:

- The next monthly *PSCA Board* meeting will be the annual meeting held during the *State Shoot* on *Saturday, July 20th*. The meeting will start at approximately **7:00 PM**.
- Motion to adjourn by *Mike Koneski*. The motion was seconded by *Mark* with all parties in favor.
