2013 PSCA Annual Meeting Minutes

Saturday July 20th, 2013

- The *PSCA* purchased **200** \$10 gift cards from *Dicks Sporting Goods*, which were given to the SCTP shooters.
- The *PSCA Board* approved the purchase of eight (8) additional gift cards to be given to those SCTP shooters who did not receive one at the shoot.

- **2013 Eastern Zone Shoot**
 - *Irene Appel* gave a brief review of the *Eastern Zone Shoot*, stating that everything ran smoothly and there were no complaints.

- **2013 Western Zone Shoot**
 - There was some discussion about the low attendance to *Western Zone Shoot*. It was stated that there was a shoot at an Ohio club which may have drawn away some Pennsylvania shooters, as well as Ohio shooters, that would have normally attended the *Western Zone*.

- **2014 Zone & State Shoots**
 - The *2014 Eastern Zone* will be hosted by *Rock Mountain Sporting Clays*. However, due to a scheduling conflict, the dates for the Eastern Zone have been changed to *June 28th and 29th, 2014*.
 - The *2014 Western Zone* will be hosted by *Castlewood Rod & Gun Club*.
 - *Ricky* informed those present that he had been informed that due to the increased cost of trap rental, *Thunder Ridge* would be unable to host the *2014 State Shoot*.
 - After a lengthy discussion, it was determined that *Thunder Ridge* would re-evaluate their shoot application to determine if an increase in the *State Shoot* events entry fees would help to offset the increased trap rental cost and allow them to host the *2014 State Shoot*. *Thunder Ridge* will provide their findings to the *PSCA Board* by the next monthly meeting in August and the decision will be made as to whether the *2014 State Shoot* will be hosted by *Thunder Ridge* or if necessary, at a possible alternate venue.

New Business

- **2015 Zone & State Shoots**
 - There were no applications submitted to host the *2015 Eastern Zone*.
 - *Castlewood* was the only club to submit an application to host the *2015 Western Zone*.
 - There were two (2) clubs that submitted applications to host the *2015 State Shoot*, *Buffer Creek* and *Stonycreek*. Ballots were available during this year's *State Shoot* and the votes will be tallied at the conclusion of this year's *State Shoot*. The results of the voting will be available on the *PSCA* website.
