Call to Order:

- The meeting was called to order at 7:05 PM by *Ricky*.

Previous Meeting Minutes:

- The *May* meeting *Minutes* were emailed to all *Board* members prior to the meeting.
- After reviewing, *Roy* motioned to accept the *May* meeting *Minutes*. The motion was seconded by *Andy* with all present in favor.

Treasurer's Report:

- The *Treasurers Report* was emailed to all *Board* members prior to the meeting.
- After a review, *Nick* motioned to accept the *Treasurers Report*. Motion was seconded by *Roy* with all present in favor.

Old Business:

- Zone Shoot Updates
 - *Nick* gave a brief recap of the *Western Zone*, stating that everything ran successfully with the exception of one station that had to be “*thrown out*” due to a malfunction. *Nick* also stated that shooter turnout was on the lighter side with between 50 & 60 shooters. *HOA* was *Ryan Smith* with *Joe Zeitler* being *Runner-Up*.
 - *Ricky* gave a brief update on the *SCTP State Shoot*, stating that there were 220 shooters at the *SCTP State Shoot* hosted by *Factoryville*.
 - *Ricky* gave an update from *Mike Koneski* concerning the *Eastern Zone*. Everything is ready for the *Eastern Zone*, and trappers have been secured for all of the events.
- *Ricky* asked *Andy* to send a check out to *Rocky Mountain Awards and Trophy* to cover the cost of the *SCTP State Shoot* trophies.
- *Ricky* also asked *Andy* to send a check out to *Castlewood* as reimbursement for the *PSCA Lewis* for the *PA Western Zone Shoot*.
- State Shoot Updates
 - *Ricky* updated those present with updates he had received from *Irene*.
 - Construction on a new pavilion will be starting next week.

- Trophies have arrived at *Thunder Ridge*.
- Working on getting trappers and as expected the hardest days to find people are for *Thursday* and *Friday*.
- *Thunder Ridge* will coordinate with *CAC Associates* to ship the ammo to be used for the *PSCA Shell Game*.
- *Irene* is working on getting the squadding information updated on the WinScore website.
- There were some concern raised about the squadding information not being up to date, leaving shooters wondering if they got their submitted rotation for various events. There was also a concern raised about the lack of a shoot flyer being available. Ricky will raise these concerns to Irene.

New Business:

- *Ricky* stated that there were still no applications from clubs wishing to host either of the *2016 PA Zone Shoots*.
- *Ricky* informed everyone that since the last meeting, two clubs had submitted applications to host the *2016 State Shoot*. The clubs were *Buffer Creek* and *Stonycreek*. However, since both of these clubs are in the western part of the state and the *2016* is supposed to be in the eastern part of PA, *Ricky* will send an email out to ALL PSCA clubs asking that any club wishing to host the *2016 State Shoot* submit an application by *5:00 PM* on *Friday June 27th, 2014*. All submitted applications will then be included on a ballot to be presented to shooters at this year's *State Shoot*.
- There was some discussion about why clubs are no longer willing to submit applications to host *State Shoots* and what could be done to encourage clubs to do so...the discussion also touched on what clubs view as the biggest concern about hosting *State Shoots*. The biggest issue discussed was the availability of qualified trappers.
- There was also discussion around utilization of the money current set aside for *PSCA Zone Shoot Lewis Class* in *2016*, should there be **NO** applications to host either of the *PA Zone Shoots*.

Next Meeting date and location:

- The next monthly *PSCA Board* meeting will be the annual meeting and will be held on *Saturday, July 19th 2014* at *Thunder Ridge Sporting Clays*. The meeting will start as soon as possible after the last rotation is complete on *Saturday*.
