 - ✓ The **PSCA** had sponsored the tee-shirts for the SCTP shooters at this year's **SCTP PA State Shoot**.

- ✓ **\$200** of PSCA funds were used to purchase snacks for shooters at the *SCTP State Shoot*.
- ✓ **Clinton Dicks** of **Lawrence County** asked if the PSCA would be consider sponsoring the tee-shirts in **2019** when **Lawrence County** will be hosting the *SCTP PA State Shoot*. **Ricky** agreed that the **PSCA** would be open to sponsoring the tee-shirts.
- **2019 State Shoots**
 - ✓ **Mike Brendle** of **Buffer Creek** asked that they be allowed to move the **2019 PA State Shoot** date so as not to conflict with the *SCTP Nationals* in Ohio. There was some confusion as to when the *SCTP Nationals* was scheduled for in **2019**, so **Mike Brendle** will find out the exact date and let the **PSCA Board** know the new proposed date for the **2019 PA State Shoot**.
 - ✓ **Mike Brendle** also requested that **Buffer Creek** be allowed to have a 100 bird Prelim FITASC event on Thursday and a squadded 100 bird Prelim Event on Friday for the **2019 PA State Shoot**. A motion to allow the changes was made by **Rodger Becker** and seconded by **Steve Edmondson** with all parties in favor.

New Business

- **Ricky** presented **Mike Brendle** with a check for the **PSCA Purse Money** in the amount of **\$7,900**.
- **2020 / 2021 State Shoots**
 - **Ricky** informed those present that **Rock Mountain** and **Stonycreek** had submitted applications for the **2020 / 2021 PA State Shoots**.
 - **Rock Mountain** received **51%** of the votes. **Stonycreek** received **48%** of the votes. The **2020 & 2021 PA State Shoots** will be at **Rock Mountain**.
- **PSCA Director-At-Large Position**
 - **Ricky** informed those present that there were four (4) candidates for the open **PSCA Director-At-Large** position with **Brady Simms** receiving the majority of the votes.
 - **Brady Simms** – 43%
 - **Randy Dotter** – 28%
 - **Mark McCummins** – 10%
 - **Bill Concolino** – 8%
