  - 170 pre-registered shooters
  - *Rock Mountain* will sponsor a separate trophy for High SxS
  - *Rock Mountain* has submitted an application for a \$2,000 grant from the NSCA
  - *Mike* has been in contact with *Rod Shyda* of *Lincoln Traps*. *Rod* will be supplying an additional 67 traps to supplement *Rock Mountain's* inventory.
  - *Brianna Manning* of NC will be serving as the *Chief FITASC* referee. *Mike* has a list of PA & NY FITASC and *Sporting Clays* referees from the NSCA supplied by *Ricky* and will be contacting individuals.
  - New shooting holes and stations
  - *Saturday* and *Sunday* of the *State Shoot* there will be a *50-bird Report/True/SuperSporting* setup on the *Short Course*.
  - *Make-It-Break & Long-Bird*
  - CAC will ship the shells for the *Shell-Game* the week prior to the *State Shoot*.
- *Ricky* mentioned that *Rodger Becker* had once again agreed to serve as the collector of election nomination forms.
- *Ricky* also mentioned that he had placed posts on the *PA Sporting Clays FaceBook* page, as well as *ShotGunWorld*, informing shooters that this year is an election year for *PSCA Officers*.
- *Ricky* stated that he has setup an account on [ElectionBuddy](#) in preparation for this year's *PSCA* election and was able to setup a test election.
