

## PSCA Meeting 10/21/07

**Location:** Blue Ridge Sportsmen's Club

**Call to Order:** The meeting was called to order at 6:00 p.m. by President Clyde Keller.

**Attendance:** Rodger Becker, Steve Stambaugh, Jeff Lutz, Clyde Keller, Scott Currey and Randall Tinsley were in attendance.

**Minutes:** Steve distributed copies of the meeting minutes. Scott made a motion to accept the minutes as presented. The motion was 2<sup>nd</sup> by Randall, with all in favor.

**Treasurer's Report:** Jeff distributed copies and reviewed the treasurer's report. The PSCA has received \$5,019.50 to date in target fees and \$175 in club memberships. There is \$4,634.93 in general unrestricted funds and \$32,800 in restricted funds allotted for the 2008/09 PSCA Shoots. Scott made a motion to accept the Treasurer's report, 2<sup>nd</sup> by Rodger with all in favor.

### **Old Business:**

**Budget:** Randall made a motion to eliminate the playing card raffle for 2 guns at the PA State Championship. The motion was 2<sup>nd</sup> by Jeff, with all in favor. The board had a 30+ minute discussion on the proposed budget which resulted in a balanced budget for 2008. Steve made a motion to accept the 2008 budget as proposed, 2<sup>nd</sup> by Rodger with all in favor. (Copy included)

**Club Packets:** The board reviewed the current information included in the club packets and approved Jeff sending it with no changes. Clyde will forward Jeff a cover letter to include.

**Target Volume Program:** The board had a 1+ hour discussion working out the details of this new program being started in 2008. The main goals of the program are to boost attendance of registered target events at clubs throughout PA and to increase the number of registered targets being shot in PA.

The program will be funded from \$5000 of the allotted PA State Championship gun budget. The PSCA will award guns and main event entry fees to various sporting clay events at the PA State Championship. These prizes will be awarded in a raffle to any NSCA member in good standing who attends the State Championship as a competitor with a backtag number. A competitor's eligibility for prizes will be based on the total number of registered targets he/she shoots in PA during the previous

calendar year. The raffle and prizes will be awarded in 6 different levels coinciding with the total number of targets shot. The levels and prizes will be broken down as follows:

<b>Eligible Level</b>	<b># of Registered Targets</b>	<b>Available Prizes</b>
Level I	500+	1 Gun
Level II	750+	3 PA Zone Shoot Entries
Level III	1000+	1 Gun + 3 PA Zone Shoot Entries
Level IV	1500 +	3 PA Zone Shoot Entries + 2 PA State Championship Entries
Level V	2000+	3 PA Zone Shoot Entries + 2 PA State Championship Entries + 1 Zone II Championship Entry
Level VI	3000+	2 PA State Championship Entries + 1 Zone II Championship Entry

Also, to jumpstart the program in 2008 there will be 1 additional gun awarded at Level I based on the number of targets shot from January 1 – May 31, 2008. Steve will put together information for Jeff to include in the club packets and to post on the PSCA website.

Website Update: Jeff will update the list of clubs with delinquent target fees.

National Delegate Update: Randall informed the board that he, Kim Spohn and Steve Edmondson will be attending the NSCA Delegate meeting at the NSCA National Championship.

**New Business:**

PSCA Shoot Sponsors/Corporate Partners: Scott informed the board that Remington came on board as a 2008 State Championship Sponsor. They would like to be located in an area adjacent to the games. They may give out shells to be used at some of the games and a model 1100 to a lucky participant.

Future Meetings: Clyde will schedule a meeting in December to finalize any revisions to the PSCA Shoot Guidelines.

Meeting Adjournment: Steve motioned to adjourn the meeting, 2<sup>nd</sup> by Jeff with all in favor. The meeting was adjourned at 9:09 p.m.
