#### 7. 2023 PA State Shoot

Roy Fritz, Stonycreek Shooting Center proposed a price increase; he submitted to the PSCA for review and approval. Neal Chadwick is scheduled to set the Main Event, FITASC, Prelim and Super Sporting.

Chris Wilhelm motioned to accept the increase, the motion was seconded by Will Brendell with all parties in agreement. The increase is as follows:

i. Main Event: \$225ii. FITASC: \$135

iii. All 100 Bird Events: \$110iv. All 50 Bird Events: \$55

- b. Registration will be found on Winscore by end of January. The dates can be found on the PSCA Calendar.
- c. Side Events will include Make a Break, Long Bird, 5-Stand Practice, Sub Gauges, SxS and Pump. All events will have Trappers.
- d. RC Ammo will be available to shooters for sale. The ammo can be ordered now and held for the State Shoot, or purchased at the time of the State Shoot..
- e. Golf carts will be available for rental; tentative pricing: 2 man \$70; 4 man \$80 per day
- f. Shell Game and Prizes: Brent will contact suppliers for Shells and Prizes.
